Mandatory Documents

1. Original Emirates ID
Please note: Visa copy may be required if the designation mentioned in the Emirates ID is not the same as in the stamped visa. Emirates Airlines/ FlyDubai cabin crew must provide visa copy if profession is different in Emirates ID.
2. Eye test must be completed before RTA file opening. It can be done at any of our main centers (Al Qusais / Al Quoz) or at any RTA authorized optical centers in Dubai.
3. Valid & original driving license issued from other country of the same category (if any):
The license must be legally translated only from Dubai if the driving license is not printed in English or Arabic.
4. Medical fitness report required if:
 - a. The customer is possessing 'Driver' visa
 - b. Customer above the age of 65 years
 - c. Drivers under the personal sponsorship and not company sponsored.
5. Commercial license permit is required if the designation on the visa is 'Driver'

Additional documents for:

Female customers willing to be trained by a male instructor: (Less than 21 years)

4. Copy of RTA learning permit
5. No objection letter signed by sponsor (father /husband). No Objection letter to be signed by self (only for UAE nationals/employment visa holders).
6. Copy of Emirates ID

Driver visa holders (excluding taxi company):

4. Medical fitness report from the RTA approved medical center/hospitals.

File transfer from other institute in Dubai/Emirates:

4. Original RTA file from the previous school/institute (if registered before April 2017)
5. No Objection letter /status report from previous school/institute.
6. Theory lectures details (if attended)
7. Valid /invalid learning permit (not applicable for other emirates)
8. Training sheet (if practical training is attended)

Customer holding partner visa:

4. Copy of valid trade license

Customer working in Dubai holding visa from other Emirate:

4. Copy of trade license in Dubai
5. Copy of trade license in other emirates (must be same as in Dubai trade license)
6. No objection letter from Dubai office stating the customer is employed and working in their Dubai office. (No Objection letter must be printed on company's letterhead with company stamp and signature of designated authority).
