2. Eye test must be completed before RTA file opening. It can be done at any of our main centers (Al Qusais/Al Quoz) or at any RTA authorized optical centers in Dubai.
3. Valid & original driving license issued from other country of the same category (if any):  
The license must be legally translated only from Dubai if the driving license is not printed in English or Arabic.
